### Midstar acquires Scandic Täby Hotel, Stockholm

Midstar Hotels acquires Scandic Täby from Maxus AB. The hotel is located in central Täby, close to E18, 2 km from Täby centrum and 10 km north of Stockholm City. The hotel was built in 1982 and consists of 170 hotel rooms, 4 meeting rooms, restaurant & bar, gym and parking.

Scandic Täby is a solid asset that has recently been extended and renovated, benefitting from a great location in Täby, close to Roslagsbanan and E18. The hotel is fully in line with Midstar's long term strategy, with the hotel catering to demand from corporate, local development projects as well as leisure and business.
